If approved your organization/group may receive one or more certificates for services or good or items for your event to be provided by the Lac du Flambeau Business Development Corporation and its Subsidiaries. The certificates will be honored up to one year from the starting date of your organizations event.

Cash Donation:

Cash donations are for organizations that are looking for a specific amount of money in support of their project or event. The max donation amount for an individual is \$250 – The max donation amount for a group or event is \$625. Amount requests for funds above the set amounts described above may be approved on a case-by-case basis depending on the need and uniqueness of the event.

- A W-9, Taxpayer Identification Request is required.

- Lac du Flambeau Business Development Corporation reserves the right to deny requests if not submitted at least 30 days in advance of your event. The review process may take longer for larger requests.
- Lac du Flambeau Business Development Corporation reserves the right to limit sponsorship(s) to one per calendar year per event/person, including Board of Directors and Tribal Council requests.
- If not a tribal government or a 501(c)(3), a reliable fiscal agent is required.
- Preference is given to requests from organizations whose activities or services significantly benefit local businesses and residents.
- If further information is required, you will be contacted.
- Should your request be declined, you will receive written notice.

At the Lac du Flambeau Business Development Corporations discretion, failure to use funds in an appropriate manner as requested may exclude potential future donations to your event/program.

The Lac du Flambeau Business Development Corporation is not liable for any persons/group or event that receives donation funds from the Lac du Flambeau Business Development Corporation.
