Cash Sponsorships

Cash sponsorships are intended for organizations/individuals who are requesting a specific monetary amount to support a non-charitable event or project. Max sponsorship amount for a group/team \$1250 – Max sponsorship amount for an individual \$500. Requests for funds above the set amounts described above may be approved on a case-by-case basis provided the BDC receives equitable marketing exposure.

Sponsorship Guidelines

- All requests need to be written, addressed Lac du Flambeau Business Development Corporation, and include a sponsorship request form.

Sponsorship Guidelines (Continued)

- If not a Tribal Government entity a reliable fiscal agent is required.
- Lac du Flambeau Business Development Corporation may require a sponsorship contract. Based on size of sponsorship and type of event/organization.
- Should your sponsorship provide any monetary winnings/awards, Lac du Flambeau Business Development Corporation may request the sponsorship amount from the property be returned within 10 days of receipt.
- If further information is required, you will be contacted through the information provided on the sponsorship request document.
- Should your request be declined, you will receive written notice.

Failure to use sponsorship funding in an appropriate manner may disqualify individuals or group(s) from future sponsorship consideration, at the discretion of the Lac du Flambeau Business Development Corporation.

The Lac du Flambeau Business Development Corporation is not liable for any persons/group or event that is sponsored by funds received from the Lac du Flambeau Business Development Corporation.

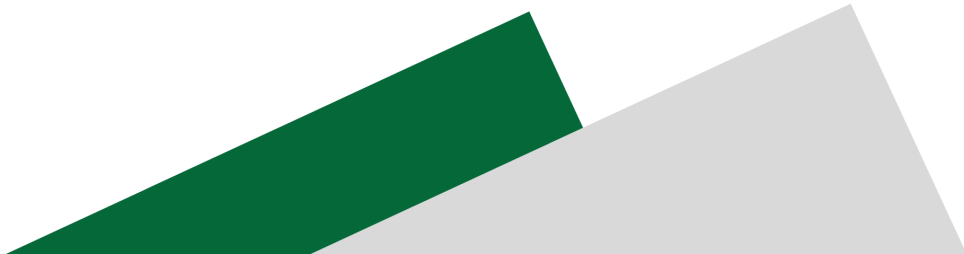

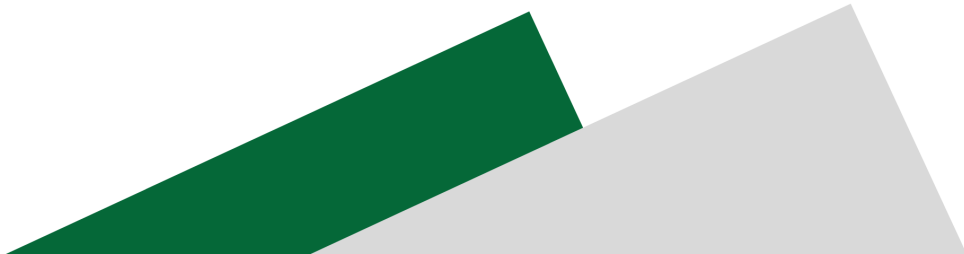
